RESOLUTION 2002- 05**

**RESOLUTION RECOGNIZING THE PERRYSBURG TOWNSHIP FIREFIGHTERS, IAFF LOCAL 4170,
AS THE EXCLUSIVE REPRESENTATIVE FOR PURPOSES OF COLLECTIVE BARGAINING**

WHEREAS, The Perrysburg Township Firefighters, IAFF Local 4170 has served upon the Perrysburg Township Board of Township Trustees, Form ERB1007, Request for Recognition, in accordance with O.R.C. Chapter 4117, OAC Rules 4117-3-01 and 4117-3-03 and Rules proscribed by the Ohio Employment Relations Board, and

WHEREAS, the Request for Recognition requests that the Perrysburg Township Board of Township Trustees recognize the Perrysburg Township Firefighters, IAFF Local 4170, as the exclusive representative for purposes of collective bargaining, and

WHEREAS, pursuant to the request for recognition, the proposed bargaining unit includes and is limited to "all full-time firefighters/EMS personnel."

NOW THEREFORE, BE IT RESOLVED BY THE PERRYSBURG TOWNSHIP BOARD OF PERRYSBURG TOWNSHIP TRUSTEES, WOOD COUNTY, STATE OF OHIO; THAT:

Section 1 Conditioned upon presentation of such proof as is satisfactory to the Township Clerk that the union does in fact represent a majority of the full time firefighters and EMS personnel, the Perrysburg Township Firefighters, IAFF Local 4170 is hereby recognized as the exclusive representative of the full time Perrysburg Township firefighters and EMS personnel for purposes of collective bargaining under terms and conditions to be negotiated with the union.

Section 2 It is hereby determined that all formal actions of Perrysburg Township Board of Township Trustees concerning and relating to the passage of this Resolution were adopted in an open meeting of this Perrysburg Township Board of Township Trustees and that all deliberations of this Perrysburg Township Board of Township Trustees and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including section 121.22 of the Revised Code of Ohio.

Section 3 This Resolution shall be effective at the earliest time permitted by law.
