RESOLUTION 2002-14

RESOLUTION INCREASING THE RATES FOR THE AMBULANCE
EFFECTIVE OCTOBER 1, 2002

WHEREAS, it is in the best interest of the health, safety and welfare of the residents of the Township to provide swift and competent ambulance and life support services; and

WHEREAS, the last time the Township raised the rates was in 1997 and there have been substantial increases in the costs of providing first rate service to the residents of Perrysburg Township and the motoring public;

NOW THEREFORE, BE IT RESOLVED BY THE PERRYSBURG TOWNSHIP BOARD OF PERRYSBURG TOWNSHIP TRUSTEES, WOOD COUNTY, STATE OF OHIO; THAT:

Section 1 Charges are to be made for ambulance and emergency medical services rendered by the Perrysburg Township Fire Department and EMS as follows: basic life support services \$200.00 for residents, advanced life support services \$325.00 for residents, non-residents basic life support services \$325.00, advanced life support services \$425.00 and all will pay a rate of \$7.00 per loaded mile for mileage.

Section 2 The clerk shall bill and collect charges made pursuant to this resolution. Money collected shall be deposited in a separate fund designated as the "ambulance and emergency medical services fund," and shall be appropriated and administered by this board for payment of the costs of managing, maintaining and operating ambulance and emergency medical service in the township.

Section 3 It is hereby determined that all formal actions of Perrysburg Township Board of Township Trustees concerning and relating to the passage of this Resolution were adopted in an open meeting of this Perrysburg Township Board of Township Trustees and that all deliberations of this Perrysburg Township Board of Township Trustees and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including section 121.22 of the Revised Code of Ohio.

Section 4 This Resolution shall be effective October 1, 2002.
