RESOLUTION AUTHORIZING A STOP SIGN AT THE INTERSECTION
OF SEDGEFIELD RD, SHEFFIELD RD, AND GOLF CREEK LANE

Resolution No. 2004-23

WHEREAS, it has come to the attention of the Board of Township Trustees that a dangerous situation exists at the corner of Sedgefield Rd, Sheffield Rd, and Golf Creek Lane in that there is no traffic control device for the traffic on Golf Creek Lane, and

WHEREAS, it will be in the best interest of public health, safety and welfare of the residents of Perrysburg Township and the motoring public to have one stop sign placed on Golf Creek Lane at the intersection of Sedgefield Rd, and Sheffield Rd to regulate the North bound flowing traffic of Golf Creek Lane.

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Perrysburg Township that the head of the maintenance department is authorized to install one stop sign on Golf Creek Lane at the corner of Sedgefield Rd and Sheffield Rd so as to create a stop at this intersection so that the handling of traffic will be facilitated and the public health, safety and welfare promoted thereby. It is the duty of all operators of vehicles to obey such traffic control apparatus, device or signal.

It is hereby determined that all formal actions of Perrysburg Township Board of Trustees concerning and relating to the passage of this Resolution were adopted in an open meeting of this Perrysburg Board of trustees and that all deliberations of this Perrysburg Township board of Trustees and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with legal requirements, including section 121.223 of the Ohio Revised Code.
