RESOLUTION NO. 2005-01

WHEREAS the Trustees of Perrysburg have determined that the intersection of Eckel Jct. Rd and State Route 199 to be a very dangerous intersection in the Perrysburg Township and:

WHEREAS the Perrysburg Township Trustees would expect West Valley Development to extend Carronade Dr. through their new housing development enabling the Trustees to close off Eckel Jct. road at State Route 199 for safety reasons. Traffic would then turn off of Eckel Jct. road on to the new extension of Carronade Dr through the new West Valley subdivision and connect to 199 south of the old Eckel Jct. road connect. The Township would follow the Ohio Department of Transportation developed plan for turn lanes north and south on 199 to access the new Carronade extension and:

WHEREAS the Trustees would allow West Valley Development two years from the purchase date of the property from the Perrysburg School system to extend the new section of Carronade to the Ohio Department of Transportation right a way of State Route 199. The Trustees then would have 12 months from that completion date to connect Carronade Dr. to State Route 199.

THEREFORE LET IT BE RESOLVED that on this 3RD of JANUARY 2005, the Trustees of Perrysburg Township hereby approve and adopt the following resolution with the best interest of the health, safety and welfare of the residents of Perrysburg Township.

It is hereby found and determined that all formal actions of Perrysburg Township Board of Trustees concerning and relating to the passage of this Resolution were adopted in an open meeting of this Perrysburg Township Board of Trustees and that all deliberations of this Board of Perrysburg Board of Trustees and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including section 121.22 of the Revised Code of Ohio.
