**RESOLUTION NO. 2005-08**

WHEREAS the Board of Trustees of Perrysburg Township has deemed it necessary to provide for a Marine Patrol of the Maumee River located within the boundaries of this Political Subdivision for the benefit of the Townships health, safety, and welfare, by the Perrysburg Township Police Department. The Township Police will enforce the watercraft laws of Ohio as set forth in Chapters 1547 and 1548 of the Ohio Revised Code and to enforce those regulations, rules, and ordinances promulgated by the state and local authorities which pertain to the operation of watercraft, and to provide emergency response to boating accidents on the water; and

WHEREAS the Board of Trustees of Perrysburg Township have appropriated the amount of \$29,888.00 in the Marine Patrol account to be used for such purpose, and to be placed with the state grant monies of \$12,912.00 when received for a total amount of \$42,800.00 in the Marine Patrol account.

NOW THEREFORE, LET IT BE RESOLVED that on this 2<sup>ND</sup> day of May 2005 the Board of Trustees of Perrysburg Township hereby approve and adopt the following resolution for the Perrysburg Township Police Department Marine Patrol. The Perrysburg Township Police Department shall patrol and enforce the aforementioned watercraft laws of Ohio on the Maumee River with a total cost of \$42,800.00. It is hereby found and determined that all formal actions of Perrysburg Township Board of Township Trustees concerning and relating to the passage of this Resolution were adopted in an open meeting of this Perrysburg Township Board of Trustees and that all deliberations of this Perrysburg Township Board of Township Trustees and of any committees that resulted in such formal action, were in meetings open to the public, in compliance with legal requirements, including section 121.22 of the Ohio Revised Code.
