**RESOLUTION NO. 2005- 09**

Perrysburg Township resolution 2005- prohibiting parking on all of Carolina Drive on both sides of the roadway.

WHEREAS, Ohio Revised Code 1505.17 permits the Board of Township Trustees to make such regulations and orders as are necessary to control all vehicle parking in the unincorporated portions of the Township, and

WHEREAS, The regulation is applicable only to the unincorporated areas of Perrysburg Township.

**NOW THEREFORE BE IT RESOLVED BY THE PERRYSBURG TOWNSHIP BOARD OF TRUSTEES, WOOD COUNTY, OHIO, THAT:**

- Section 1.** Parking shall be prohibited on Carolina Drive on both sides of the roadway
- Section 2.** This regulation is subject to limitations, restrictions and exceptions in Ohio Revised Code Chapters 4511 and 4513.
- Section 3.** Whoever violates this regulation shall be guilty of minor misdemeanor.
- Section 4.** Fines levied pursuant to this regulation shall be paid to the clerk of the Township at such time and place as shall be designated on the ticket issued by the ticketing officer.
- Section 5.** The Township clerk is directed to post these regulations in five (5) conspicuous public places in the Township for thirty (30) days and publish the same in a newspaper of general circulation in the Township for three (3) consecutive weeks.
- Section 6.** It is hereby determined that all formal actions of Perrysburg Township Board of Trustees concerning and relating to the passage of this Resolution were adopted in an open meeting of this Perrysburg Township Board of Trustees and that all deliberations of this Perrysburg Township Board of Township Trustees and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with legal requirements, including section 121.22 of the Ohio Revised Code.
