RESOLUTION 2007-01**

**RESOLUTION INCREASING THE RATES FOR AMBULANCE BILLING EFFECTIVE
01-17-2007**

Whereas, it is in the best interest of the community that Perrysburg Township be able to provide swift and competent basic and advanced life support services in order to ensure the health, safety, and welfare of the residents and those passing through Perrysburg Township; and

Whereas, the last time Perrysburg Township raised its rates for basic and advanced life support transports was in 2002 and there have been substantial increases in the costs of providing first rate service to the residents and those passing through Perrysburg Township;

NOW THEREFORE, BE IT RESOLVED BY THE PERRYSBURG TOWNSHIP BOARD OF PERRYSBURG TOWNSHIP TRUSTEES, WOOD COUNTY, STATE OF OHIO; THAT:

Section 1 Charges are to be made for basic and advanced life support services rendered by Perrysburg Township Fire/EMS as follows:

- Basic life support services for residents shall be \$250.00.
- Advanced life support 1 services for residents shall be \$350.00.
- Advanced life support 2 services for residents shall be \$450.00.
- Basic life support services for non-residents shall be \$425.00.
- Advanced life support 1 services for non-residents shall be \$450.00.
- Advanced life support 2 services for non-residents shall be \$550.00.
- All will pay a rate of \$7.00 per loaded mile for mileage.
- Patient's requiring ALS 1 or 2 level care that sign AMA, are released at the scene, or are not transported for other reasons will be billed according to the above pay scale.
- Patient's who are transported by air ambulance will be billed according to the above pay scale.

Section 2 The fiscal officer and/or the EMS billing clerk shall bill and collect charges made pursuant to this resolution. Money collected shall be deposited in a separate fund designated as the Perrysburg Township Fire/EMS-Emergency Medical Services Fund. Monies in this account shall be appropriated and administered by this board for payment of the costs of managing, maintaining, and operating the Perrysburg Township department of fire and EMS.
