RESOLUTION 2007- 01 AMENDING RESOLUTION 231.80 DATED JANUARY 21, 1980

WHEREAS, the Trustees of Perrysburg Township find it necessary to amend resolution 231.80: 'No Wake' Limitation on the waters of the Maumee River within the jurisdiction of Perrysburg Township and,

WHEREAS, it is in the best interest of the health, safety, and welfare of the residents of Perrysburg Township to have the existing five mile per hour speed limitation of the Maumee River removed and changed to a 'No Wake' limitation Said 'No Wake' limitation being easier to enforce and,

WHEREAS, said 'No Wake' limitation on the Maumee River within the geographical boundaries of Perrysburg Township shall be posted by the placing of buoys in the Maumee River. The type and characteristic of these buoys to be approved by the Commander, Ninth Coast Guard District, 1240 East Ninth Street, Cleveland, Ohio, 44199 and,

WHEREAS, Perrysburg Township will assume: all responsibility for the placing and the maintenance of all navigational buoys within its jurisdiction.

NOW THEREFORE BE IT RESOLVED, by said Board of Township Trustees that the five mile per hour regulation presently posted in the Maumee River within the geographical boundaries of Perrysburg Township be and hereby is changed to a 'No Wake' limitation by the placing of buoys in the Maumee River. This resolution shall be submitted to the Ohio Department of Natural Resource's Division of Watercraft, 2045 Morse Road, Building A-2 Columbus, Ohio 43229 for adoption under Ohio Revised Code, Section 1547.521 authorizing State Watercraft Officers to enforce its regulation.

It is hereby determined that all formal actions of the Perrysburg Township Board of Trustees concerning and relating to the passage of this resolution were adopted in an open meeting of this Perrysburg Township Board of Trustees and that all deliberations of this Perrysburg Township Board of Trustees and any of its committees that resulted in such formal actions, were in meetings open to the public, in compliance with legal requirements, including section 121.22 of the Ohio Revised Code.
