RESOLUTION 2002-07

RESOLUTION PROHIBITING PARKING AT SPECIFIC LOCATIONS  
ON GLENWOOD ROAD IN PERRYSBURG TOWNSHIP

WHEREAS, The Board of Trustees of Perrysburg Township, Wood County, Ohio, has determined that vehicles parked on the west side of Glenwood Road within 500 feet to the north of State Route 20 interfere with the public safety and welfare of the Township and its residents; and

WHEREAS, The Board of Trustees of Perrysburg Township, Wood County, Ohio, has determined the public safety and welfare would be served by restricting parking at that location; and

WHEREAS, The regulation does not conflict with the Uniform Traffic Act and is applicable only to the unincorporated areas of the Township;

NOW THEREFORE BE IT RESOLVED BY THE PERRYSBURG TOWNSHIP BOARD OF PERRYSBURG TOWNSHIP TRUSTEES, WOOD COUNTY, OHIO; THAT:

- 1) Parking on the west side of Glenwood Road within 500 feet to the north of State Route 20 is hereby prohibited;
- 2) The location indicated shall be further designated by the installation of an appropriate traffic control device conforming to Ohio Revised Code Section 4511.09;
- 3) Whoever violates this regulation shall be guilty of a minor misdemeanor;
- 4) Fines levied pursuant to this regulation shall be paid to the Clerk of the Township at such time and place as shall be designated on the ticket issued by the ticketing officer;
- 5) This regulation is subject to the limitations, restrictions, and exceptions in Ohio Revised Code Chapter 4511 and Ohio Revised Code Section 4513.02 to 4513.37;
- 6) It is hereby found and determined that all formal actions of Perrysburg Township Board of Township Trustees concerning and relating to the passage of this Resolution were adopted in an open meeting of this Perrysburg Township Board of Township Trustees and that all deliberations of this Perrysburg Township Board of Township Trustees and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including section 121.22 of the Revised Code of Ohio.
- 7) This resolution shall take effect at the earliest time as permitted by law.
