Organizational Meeting  
January 14, 2008

The Perrysburg Township Zoning Commission held an organizational meeting on January 14, 2008, at 26609 Lime City Road, Perrysburg, Ohio. Acting Chairman Robert S. Black called the meeting to order at 6:00 p.m., said good evening to everyone in attendance, and said they will start with the ZC organizational meeting. A roll call was taken. Grant W. Garn, Zoning Inspector, was also present. The meeting was tape-recorded.

MEMBERS PRESENT: John Benavides, Robert S. Black, Jeff Schaller, Carol Warnimont, and Ronald M. Hanna.

MEMBERS ABSENT: Arthur Rometo and Jeffrey Normand.

ELECTION OF OFFICERS: Mr. Black said the first item on the agenda is the election of officers. He said they will start off with chairman of the zoning board, and he asked if there were any nominations for chairman of the Perrysburg Township Zoning Commission. Mr. Schaller moved with a second by Ms. Warnimont to nominate Mr. Black as chairman. Mr. Black asked if there were any other comments or any other volunteers, and there were none. Mr. Schaller asked if there were any objections. Mr. Black said he does enjoy it, and he thanked them for their confidence in him. A roll call vote was taken. Yes votes by Mr. Schaller, Ms. Warnimont, Mr. Benavides, and Mr. Hanna. Mr. Black abstained. Motion carried 4-0-1.

Mr. Black said the next item on the agenda is the election of a vice chairman of the Perrysburg Township Zoning Commission. Mr. Black moved with a second by Mr. Benavides to nominate Jeff Schaller as the vice chairman. Mr. Garn asked who the second was on that, and he was informed it was Mr. Benavides. A roll call vote was taken. Yes votes by Mr. Black, Mr. Benavides, Mr. Hanna, and Ms. Warnimont. Mr. Schaller abstained. Motion carried 4-0-1.

Mr. Black said thank you to Mr. Garn and said the next item is the nomination of a secretary of the Perrysburg Township Zoning Commission. Mr. Black moved with a second by Mr. Benavides to nominate Carol Warnimont as secretary. A roll call vote was taken. Yes votes by Mr. Black, Mr. Benavides, Mr. Hanna, and Mr. Schaller. Ms. Warnimont abstained. Motion carried 4-0-1.

Mr. Black asked if there was a motion to adjourn their organizational meeting of the Perrysburg Township Zoning Commission. Mr. Hanna moved with a second by Mr.

Schaller to adjourn. All members were in favor, and none were opposed. Motion carried 5-0-0. The organizational meeting was adjourned at 6:05 p.m.
