## **Board of Zoning Appeals Organizational Meeting Minutes January 9, 2012**

The Perrysburg Township Board of Zoning Appeals held a meeting on January 9, 2012.

Mr. Miller, as acting Chair of the Perrysburg Township Board of Zoning Appeals called the meeting to order at 7:00 p.m. He stated that they would initially have their Organizational Meeting and informed those present that they would adjourn this meeting and reconvene for business matters before the Board. He then asked Mr. Garn to please call the roll.

Mr. Miller stated they had a quorum to conduct business and that the purpose of this meeting was to organize the Board of Zoning Appeals for the year 2012. He declared the floor open for nominations for Chairman of the Board of Zoning Appeals. **Mr. Justus made a motion to nominate Mr. Miller (Mr. Irwin seconded)**. Mr. Miller stated there was a motion and a second. He then asked if there were any other nominations; there were none and Mr. Miller declared the nominations closed. If not the Chair would entertain a motion to adjourn. ***Mr. Warnimont made a motion to adjourn (Mr. Irwin seconded)***. With no discussion, Mr. Miller asked Mr. Garn to please call roll. *YES- Mr. Warnimont, Mr. Irwin, Mr. Bennett, Mr. Justus, and Mr. Miller. Motion carried.*
