Board of Zoning Appeals Meeting Minutes January 15, 2013

Mr. Miller, as Chair of the Perrysburg Township Board of Zoning Appeals, called the meeting to order at 6:05 p.m. He then asked Mrs. Hemminger to please call the roll.

Members present: Mr. Miller, Mr. Irwin, Mr. Bennett, Mr. Justus, and Mr. Warnimont

Members absent: Ms. Hetman

Mr. Miller moved on to the first matter of approval, the September 18, 2012 meeting minutes. Mr. Miller asked if there were any questions and then solicited a motion to approve the September 18, 2012 minutes. **Mr. Warnimont made a motion to approve of the minutes (Mr. Bennett seconded)**. Mr. Miller stated there was a motion and a second to approve and asked if there was any further discussion. With no discussion, Mr. Miller asked Mrs. Hemminger to please call roll. *YES- Mr. Warnimont, Mr. Bennett, Mr. Miller. ABSTAIN: Mr. Irwin and Mr. Justus. Motion carried.*

Mr. Justus brought up Mr. Sturgill who had requested not to renew his position on the Board of Zoning Appeals. **Mr. Justus wished to thank Mr. Sturgill on his many years of service and made a motion to publically thank Mr. Sturgill (Mr. Miller seconded)**. Mr. Miller asked Mrs. Hemminger to take a roll on this motion. *YES- Mr. Justus, Mr. Miller, Mr. Irwin, Mr. Bennett, and Mr. Warnimont. Motion carried.* Mrs. Hemminger stated Mr. Sturgill would like to continue as an alternate. She also mentioned Ms. Hetman to stay on as an alternate. Mr. Miller stated Mr. Warnimont had indicated he is willing to serve in that capacity. Mr. Miller asked Mrs. Hemminger to approach the Board of Trustees to approve this.

The Chair entertained a motion to adjourn. **Mr. Warnimont made a motion to adjourn (Mr. Bennett seconded)**. Mr. Miller asked Mrs. Hemminger to please call roll. *YES- Mr. Warnimont, Mr. Bennett, Mr. Miller, Mr. Irwin, and Mr. Justus. Motion carried.*
