RESOLUTION 2013-04
**Participation in ODOT Cooperative
Purchasing Program**

The Board of Trustees of Perrysburg Township, Wood County, Ohio met at a regular meeting of the Board, on February 27, 2013; whereupon the following was placed in consideration on the regular agenda of the Board:

WHEREAS, Section 5513.01 (B) provides the opportunity for Counties, Townships, Municipal Corporations, Conservancy Districts, Township Park Districts, Park Districts created under Chapter 1545 of the Revised Code, Port Authorities, Regional Transit Authorities, Regional Airport Authorities, Regional Water and Sewer Districts, County Transit Boards, State Universities or Colleges to participate in contracts of the Ohio Department of Transportation for the purchase of machinery, material, supplies or other articles.

NOW, THEREFORE, IT IS RESOLVED by the Board of Trustees of Perrysburg Township

SECTION 1: That Walt Celley hereby requests authority in the name of Perrysburg Township to participate in the Ohio Department of Transportation contracts for the purchase of machinery, materials, supplies or other articles which the Department has entered into pursuant to Ohio Revised Code Section 5513.01 (B).

SECTION 2: That Walt Celley is hereby authorized to agree in the name of Perrysburg Township to be bound by all terms and conditions as the Director of Transportation prescribes.

SECTION 3: That Walt Celley is hereby authorized to agree in the name of Perrysburg Township to directly pay vendors, under each such contract of the Ohio Department of Transportation in which Perrysburg Township participates, for items it receives pursuant to the contract.

SECTION 4: That Perrysburg Township agrees to be responsible for resolving all claims or disputes arising out of its participation in the cooperative purchasing program under Section 5513.01(B) of the Ohio Revised Code. The Perrysburg Township agrees to waive any claims, actions, expenses, or other damages arising out of its participation in the cooperative purchasing program which the Perrysburg Township may have or claim to have against ODOT or its employees, unless such liability is the result of negligence on the part of ODOT or its employees.

BE IT FURTHER RESOLVED, that it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of this Board and that all deliberations of this Board that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including §121.22 of the Revised Code of Ohio.
