**RESOLUTION 2013-16**  
**PROVIDING FOR THE ABATEMENT, CONTROL  
OR REMOVAL OF VEGETATION, GARBAGE,  
REFUSE, AND OTHER DEBRIS FROM LAND IN  
THE TOWNSHIP.**

**25606 Broad**

**WHEREAS**, land in the township located at 25606 Broad, owned by Michelle Paschen, contains vegetation, garbage, refuse, and other debris;

**WHEREAS**, said land has been inspected by the Township Zoning Administrator and the condition thereof reported to the Board of Trustees;

**WHEREAS**, the Board of Trustees has determined that the owner's maintenance of such vegetation, garbage, refuse, and other debris constitutes a nuisance within the meaning of Ohio Rev. Code §505.87;

**WHEREAS**, the Board of Trustees has determined that an emergency exists; and

**WHEREAS**, the proceedings and hearings on this Resolution, and any necessary notices of such proceedings and hearings have all been undertaken, conducted and given in accordance with applicable law:

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Perrysburg Township, Wood County, Ohio that:

Section 1.      The owner of said land in Perrysburg Township, Wood County, Ohio is hereby ordered to abate, control, or remove the vegetation, garbage, refuse, and other debris, the maintenance of which has been determined by the Board of Trustees to be a nuisance.

Section 2.      If such vegetation, garbage, refuse, or other debris is not abated, controlled, or removed, or provision for its abatement, control, or removal is not made within the time provided by law, the Board of Trustees will provide for the abatement, control or removal and any expenses incurred by the Township in performing that task will be entered upon the tax duplicate and will be a lien upon the land from the date of entry.

Section 3.      The Township Law Director shall give notice in accordance with R.C. 505.87(B)(2).

Section 4.      If, within seven days after notice is complete, the owner of the land fails to abate, control, or remove the vegetation, garbage, refuse or other debris, the Township may provide for the abatement, control, or removal and employ any necessary labor, materials, and equipment to perform the task.

Section 5. Upon receipt of notification of completion of removal of the vegetation, garbage, refuse or other debris, the Township Fiscal Officer shall assemble the total cost in accordance with R.C. 505.87(D) and shall certify the total cost to the Wood County Auditor to become a lien upon the lands and collected as other taxes and returned to the Township General Fund.

Section 6. The Board determines the existence of an emergency.

**WHEREUPON** Trustee **Mack** moved and Trustee **LaHote** seconded the adoption of the Resolution; and the roll was called on the question of adoption thereof; resulting as follows:


