RESOLUTION 2014-30
Registration and Regulation of Transient
Vendors

The Board of Trustees of Perrysburg Township, Wood County, Ohio met at a regular meeting of the Board, on October 15, 2014; whereupon the following was placed in consideration on the regular agenda of the Board:

WHEREAS, a board of township trustees may, by resolution pursuant to Ohio Revised Code section 505.94, require the registration of transient vendors and regulate the time, place and manner in which such vendors may sell, offer for sale or solicit orders for future delivery of goods; and

WHEREAS, the Board of Trustees of Perrysburg Township have determined that it is in the public interest to require the registration of transient vendors and regulate their activities;

NOW THEREFORE, IT IS RESOLVED by the Board of Trustees of Perrysburg Township, who voted as certified below:

1. That transient vendors selling or soliciting within the Township shall register with the Perrysburg Township Police Department in accordance with the requirements set forth in the Regulations for Transient Vendors, which are attached hereto and incorporated herein;
2. That the activities of transient vendors are hereby regulated in accordance with the Regulations for Transient Vendors, which are attached hereto and incorporated herein;
3. That the Township Administrator shall notify the prosecuting attorneys of Wood County and Perrysburg Municipal Court of the registration and regulatory requirements established hereby;
4. That the Township Road Superintendent shall obtain and post signs in sufficient numbers and locations as will fairly apprise transient vendors of the requirements imposed by this Resolution; and
5. That the Regulations for Transient Vendors established by this Resolution shall become effective upon the occurrence of the notification of prosecuting attorneys and posting of signs as aforesaid.

BE IT FURTHER RESOLVED, that it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of this Board and that all deliberations of this Board that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including §121.22 of the Revised Code of Ohio.

WHEREUPON Trustee Mack moved and Trustee Britten seconded the adoption of the Resolution; and the roll was called on the question of adoption thereof; resulting as follows:


