RESOLUTION 2014-37

Establishing the necessity for traffic regulation (Temporary Closure of Scheider Road at SR 199)

The Board of Trustees of Perrysburg Township, Wood County, Ohio met at a regular meeting of the Board, on December 17, 2014; whereupon the following was placed in consideration on the regular agenda of the Board:

WHEREAS, township regulation of the use of township roads or highways which does not conflict with standards set by statute or specific powers vested in other authorities is a valid exercise of police power under Ohio Revised Code §4511.07(I);

WHEREAS, the intersection of Scheider Road and Eckel Junction Road at SR 199 affects vehicle travel within Perrysburg Township, the City of Perrysburg and over the Ohio Department of Transportation state route;

WHEREAS, the said agencies have undertaken a lengthy and thorough cooperative study of travel through the intersection and have determined that the temporary closure of Scheider Road, in conjunction with certain other measures under the jurisdiction of the other agencies, is necessary to reduce the risk of motor vehicle accidents at the intersection;

WHEREAS, it has been determined that the health, safety and welfare of the traveling public will be improved by the temporary closure of Scheider Road where the road intersects with SR 199 in Perrysburg Township;

WHEREAS, such regulation is reasonable, is not discriminatory, is of uniform operation, has a real and substantial relation to its purpose and does not interfere with private rights beyond the necessities of the situation;

WHEREAS, the proceedings and hearings on this Resolution, and any necessary notices of such proceedings and hearings have all been undertaken, conducted and given in accordance with applicable law; and

IT IS HEREBY RESOLVED, by the Board of Trustees for Perrysburg Township, who voted as certified below:

1. That there shall be erected and maintained on Scheider Road, suitable traffic control signals and devices, such as conform to the Ohio Department of Transportation manual on a uniform system of traffic control devices; as will temporarily prevent vehicular access to Scheider Road, from or across SR 199; or from Scheider Road, to or across SR 199.
2. That the temporary closure is hereby scheduled to occur by January 15, 2015.
3. That the expenditure of any moneys available to be legally expended for the erection of said suitable traffic control signals and devices is hereby approved, effective as

of the date of this Resolution.

WHEREUPON Trustee Mack moved and Trustee LaHote seconded the adoption of the Resolution; and the roll was called on the question of adoption thereof; resulting as follows:


