RESOLUTION 2015-01
**Establishing the Necessity for Traffic
Regulation (No Engine Braking on Glenwood
and Latcha Roads)**

The Board of Trustees of Perrysburg Township, Wood County, Ohio met at a regular meeting of the Board, on January 7, 2015; whereupon the following was placed in consideration on the regular agenda of the Board:

WHEREAS, township regulation of the use of township roads or highways which does not conflict with standards set by statute or specific powers vested in other authorities is a valid exercise of police power under Ohio Revised Code §4511.07(I);

WHEREAS, townships are specifically authorized to regulate engine noise under RC 505.17 and RC 4513.221;

WHEREAS, it has been determined that the health, safety and welfare of the traveling public, the residents and businesses will be improved by the establishment of 'no engine braking' zones on:

Latcha Road - between Glenwood Road and Oregon Road

Glenwood Road - between US 20 and Buck Road

WHEREAS, such regulation is reasonable, is not discriminatory, is of uniform operation, has a real and substantial relation to its purpose and does not interfere with private rights beyond the necessities of the situation;

WHEREAS, the proceedings and hearings on this Resolution, and any necessary notices of such proceedings and hearings have all been undertaken, conducted and given in accordance with applicable law; and

IT IS HEREBY RESOLVED, by the Board of Trustees for Perrysburg Township, who voted as certified below:

1. That there shall be erected and maintained on Latcha and Glenwood Roads, suitable traffic control signals and devices, such as conform to the Ohio Department of Transportation manual on a uniform system of traffic control devices; as will prohibit engine braking in certain zones within the unincorporated territory of Perrysburg Township, specifically:

Latcha Road - between Glenwood Road and Oregon Road

Glenwood Road - between US 20 and Buck Road

2. That the regulations shall become effective at such time as all conditions of RC 505.17 are met.


3. That the expenditure of any moneys available to be legally expended for the erection of said suitable traffic control signals and devices is hereby approved, effective as of the date of this Resolution.
