## **RESOLUTION 2015-07**

Declaring the intent to sell property  
by Internet Auction

The Board of Trustees of Perrysburg Township, Wood County, Ohio met at a regular meeting of the Board, on March 18, 2015; whereupon the following resolution came on for consideration on the approved agenda of the Board:

WHEREAS, Ohio Revised Code §505.10 provides the authority for a township board of trustees to sell by internet auction, personal property including, but not limited to, motor vehicles, road machinery, equipment, tools, or supplies, that is not needed for public use, is obsolete, or is unfit for the use for which it was acquired; and

WHEREAS, the Perrysburg Township Board of Trustees intends to sell such property by internet auction;

NOW, THEREFORE BE IT RESOLVED by the Perrysburg Township Board of Trustees, Wood County, Ohio, that:

SECTION 1: Items approved for disposition will be listed on internet auction websites limited to local, county, or state government agencies; and

SECTION 2: All auctions will be of no less than ten days duration, including Saturdays, Sundays and legal holidays; and

SECTION 3: All property will be offered "As Is, Where Is"; and

SECTION 4: All auctions will be conducted according to the standard Agreement Terms and Conditions of the respective websites; and

SECTION 5: A notice of the Perrysburg Township Board of Trustees intent to sell unneeded, obsolete, or unfit for use township personal property by internet auction will be published in the newspaper once per year; and

SECTION 6: A similar notice shall be posted continually in a conspicuous place in the township Administrative Offices and on the township's web site.

BE IT FURTHER RESOLVED, that it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of this Board and that all deliberations of this Board that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

WHEREUPON Trustee Britten moved and Trustee LaHote seconded the adoption of the Resolution; and the roll was called on the question of adoption thereof; resulting as follows:


