RESOLUTION 2015-16

**Establishing the Necessity for Traffic
Regulation (No Parking on Ft. Meigs Blvd.)**

The Board of Trustees of Perrysburg Township, Wood County, Ohio met at a regular meeting of the Board, on June 17, 2015; whereupon the following was placed in consideration on the regular agenda of the Board:

WHEREAS, township regulation of the use of township roads or highways which does not conflict with standards set by statute or specific powers vested in other authorities is a valid exercise of police power under Ohio Revised Code §4511.07(I);

WHEREAS, townships are specifically authorized to regulate parking under RC 505.17;

WHEREAS, the Township Trustees are in receipt of a request by owners of property on Ft. Meigs Boulevard requesting parking regulations and attesting to the need for such regulations to provide for access by public safety vehicles and equipment and curtail on street parking by non-residents;

WHEREAS, it has been determined that the health, safety and welfare of the traveling public and the residents on Ft. Meigs Boulevard will be improved by the establishment of a 'no parking' zone;

WHEREAS, such regulation is reasonable, is not discriminatory, is of uniform operation, has a real and substantial relation to its purpose and does not interfere with private rights beyond the necessities of the situation; and

WHEREAS, the proceedings and hearings on this Resolution, and any necessary notices of such proceedings and hearings have all been undertaken, conducted and given in accordance with applicable law;

IT IS HEREBY RESOLVED, by the Board of Trustees for Perrysburg Township, who voted as certified below:

1. That there shall be erected and maintained on Ft. Meigs Boulevard, suitable traffic control signals and devices, such as conform to the Ohio Department of Transportation manual on a uniform system of traffic control devices; as will prohibit on-street parking on Ft. Meigs Boulevard in such portions of the roadway as are deemed necessary and are within the Township road right of way.
2. That the regulations shall become effective at such time as all conditions of RC 505.17 are met.
3. That the expenditure of any moneys available to be legally expended for the erection of said suitable traffic control signals and devices is hereby approved, effective as of the date of this Resolution.

WHEREUPON Trustee LaHote moved and Trustee Britten seconded the adoption of the Resolution; and the roll was called on the question of adoption thereof; resulting as follows:


