## **RESOLUTION 2015-19**

Disposition of Township Property

The Board of Trustees of Perrysburg Township, Wood County, Ohio met at a regular meeting of the Board, on August 4, 2015; whereupon the following resolution came on for consideration on the approved agenda of the Board:

WHEREAS, the Board of Trustees for Perrysburg Township have determined that the following property is not needed for public use, is obsolete, or is unfit for the use for which it was acquired: see attached list (the "Property"); and

WHEREAS, each piece of the Property has a fair market value of less than two thousand five hundred dollars; and

WHEREAS, disposition of the Property in accordance with R.C. 505.10 is appropriate:

NOW, THEREFORE BE IT RESOLVED by the Perrysburg Township Board of Trustees, Wood County, Ohio, that:

SECTION 1. The Property shall be sold by internet auction, in accordance with R.C. 505.10(D).

BE IT FURTHER RESOLVED, that it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of this Board and that all deliberations of this Board that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


