The property owner(s) shall verify any existing easement(s) and/or right-of-way(s). **Zoning Certificates shall be issued only in conformity with the provisions of the Perrysburg Township Zoning Resolution unless the Zoning Inspector receives a written order from the Board of Zoning Appeals. Any certificate issued upon a false statement of any fact shall be voidable at the discretion of the Zoning Inspector.**

The owner(s)/agent(s) must notify the Perrysburg Township Zoning Inspector when work starts so that the premises may be inspected, during the construction phase and there after, for compliance with the Zoning Resolution. The applicant shall remove debris and dirt from the roads or streets, deposited as a result of the construction process, daily (ORC Section 5589.99).
